ORDER

(Date of Order: 17.08.2012)

1. The Petitioner prayed to the Commission to approve the incentive based on the availability of transmission system of DTL for the year 2010-11.

- 2. The Commission heard the petitioner and the respondents regarding the record of final computation of availability of transmission system and calculations for incentive based on availability of transmission system. The Petitioner submitted on the last date of hearing that the issue of availability of transmission system for FY 2010-11 as 98.58% was discussed in the meeting of Grid Coordination Committee on 08.05.2012 and the minutes of the said GCC are awaited.
- 3. In compliance of the Commission's direction Petitioner submitted the approval of GCC for the availability of Transmission System of DTL as 98.58% as reconciled/approved by the stakeholders for the year 2010-11 in 6th meeting of GCC.
- 4. In view of the above, the Commission has accepted the availability of DTL Transmission System as 98.58% for the FY 2010-11 and directs that DTL may raise incentive bills based on the above availability in accordance with the provisions of the MYT Regulations.
