ORDER

1. Mr, Bhupender Nath, G.M. (Comml) DTL submitted that a meeting was held in the Chamber of Director (O) on 10th December, 2003 to discuss various issues for arranging power supply to Sonia Vihar Station. In the said meeting, representative of Delhi Jal Board & BSES Yamuna Power Limited agreed that DTL shall install the 4th 20MVA, 66/11 KV Power Transformer at South of Wazirabad alongwith associated equipments at the cost of the Discom. Subsequently, BYPL agreed for implementation of the work by DTL.

- 2. Mr. Nath, submitted that inspite of several requests made by DTL no payment has been released by BYPL till date.
- 3. Mr. Nath, further submitted that the Commission may issue necessary directions to BYPL to pay the principal amount alongwith carrying cost @ 11.5%.
- 4. Mr. Pawan Kumar, Legal Officer, appearing for BYPL submitted that the said Power Transformer is an asset of the DTL and is installed within the substation of the DTL. Further the transformer has not been transferred to BYPL.
- 5. The Commission heard both the parties at length. The Commission further directed both the parties to resolve this issue mutually within four weeks and inform the Commission accordingly.
- 6. List the matter on 17th November, 2011.
- 7. Ordered Accordingly.
