<u>ORDER</u>

(Date of Hearing: 19.08.2014) (Date of Order: 26.08.2014)

- 1. The instant Review Petition has been filed by M/s TPDDL for review of following two issues in the Tariff Order dated 31.07.2014:
 - (i) inclusion of Rs. 26.32 Crore towards true up of power purchase cost for FY 2011-12; and
 - (ii) deduction of arrears of DTL from FY 2009-10 instead of FY 2008-09.

- 2. On the date of last hearing it was decided that the tariff division may examine the issues and put up its comments on the prayer of the Petitioner.
- 3. The Commission observed that as per the comments received from the Tariff Division both the issues raised by the Petitioner have already been addressed in the tariff order for the current financial year 2014-15.
- 4. However, the Counsel for the Petitioner submitted that the year of accounting for Rs. 26.82 crore needs a correction and the issue of arrears of DTL has not been redressed completely in the tariff order for the current financial year and may require to be reconciled.
- 5. The Commission directed the Tariff Division of DERC to convene a meeting with the officers of the Petitioner to sort out the issues and to submit its report to the Commission within 3 weeks.
- 6. The next date of hearing will be intimated in due course.
- 7. Ordered accordingly.
