INTERIM ORDER

(Date of Hearing 13.03.2018) (Date of Order: 27.03.018)

- 1. The instant petition has been filed by Indian Wind Power Association (IWPA) for seeking directions for compliance of the Renewable Purchase Obligation (RPO) imposed upon the obligated entities in the state of Delhi.
