- EXTENSION OF LAST DATE FOR RECEIPT OF OBJECTIONS/COMMENTS ON DRAFT MULTI-YEAR TARIFF (MYT) REGULATIONS FOR THE CONTROL PERIOD FROM FY 2012-13 to 2014-15
 - PUBLIC HEARING ON 14.11.2011 TO CONSIDER DRAFT MULTI-YEAR TARIFF (MYT) REGULATIONS FOR THE CONTROL PERIOD FROM FY 2012-13 to 2014-15
- Delhi Electricity Regulatory Commission (Terms & Conditions for determination of Generation, Transmission and Wheeling Tariff & Retail Supply Tariff) Regulations, 2007 have been extended upto 31st March, 2012. In exercise of powers vested under sub-section (zd), (ze) and (zf) of Section 181 (2) read with Section 61, 62 and 86 of the Electricity Act, 2003 (36 of 2003) and all powers enabling it in that behalf, the Commission has prepared the Draft MYT Regulations for Control Period from 1st April, 2012 to 31st March, 2015.
- 2. The Commission vide its Public Notice dated 02.10.2011 sought objections/comments from Stakeholders on draft Multi-Year Tariff (MYT) Regulations for the Control Period from FY 2012-13 to 2014-15. The last date for receipt of objections/comments from stakeholders was 24.10.2011.
- 3. On the request of a few stakeholders the Commission has decided to extend the last date for receipt of objections/comments from Stakeholders to 08.11.2011.
- 4. The Draft Regulations along with a Concept Note on Draft MYT Regulations may be downloaded from the website of the Commission. www.derc.gov.in
- 5. Copy of the Draft Regulations and the Concept Note on Draft MYT Regulations would be available for sale at the Commission on any working day from the date of publication of this Public Notice to 08.11.2011 between 11:00am to 5:00 pm against the payment of Rs. 100/- either by Cash or by Demand Draft/Pay Order payable to Secretary, DERC at New Delhi.
