<u>ORDER</u>

(Date of Hearing: 19.12.2019) (Date of Order: 18.02.2020)

 The aforesaid review Petitions have been filed by M/s BSES Yamuna Power Ltd. in respect of the Order dated 28.05.2019 and 21.06.2019 in Petition No. 02 of 2019 and Petition No. 28 of 2019, respectively. <u>Vide</u> the aforesaid orders PPAC to the Petitioner was allowed as indicated below:

Further, the Petitioner was directed to claim the differential PPACs through ARR Petition for FY 2019-20 as the period of recovery was already over.

2. The Petitioner has submitted that the Petitioner raised the claim for the differential PPAC in its ARR proceedings for the FY 2019-20, however, the same had not been subsumed in revised tariff for the FY 2019-20, therefore, the Petitioner has sought review of the Orders dated 28.05.2019 and 21.06.2019 in Petition No. 02 of 2019 and Petition No. 28 of 2019, respectively, and to permit the Petitioner to recover the differential PPAC in the forthcoming months.

- 3. The contention of the Petitioner has been examined and it is observed that the aforesaid differential PPACs have not been subsumed in the tariff for the FY 2019-20. The cumulative PPAC for the two quarters is 5.85%. The Petitioner may be allowed to recover PPAC @ 2.925% in two quarters. Accordingly, the direction to claim PPAC through ARR as contained in para 3.iii of the aforesaid Orders is modified and the Petitioner is directed to recover differential PPAC @ 2.925% (i.e. ½ x 5.85%) in two quarters i.e. 6 months."
- 4. Ordered accordingly.
