> ORDER (Date of Order: 30/06/2022)

- 1) In Compliance of Hon'ble Delhi High Court Order dated 1/06/2022 in Writ Petition No. 5340 of 2022 filed by BSES DISCOMs and Writ Petition No. 6735 of 2022 filed by TPDDL, Ministry of Power (MoP), Govt. of India vide its Office Memorandum No. 22-301/1/2022-OM [262443] dated 28/06/2022, had reallocated around 500 MW of Delhi's share to Haryana with immediate effect and balance 228 MW is continued to be utilized by Delhi till 31/10/2022. Further, in the said letter MoP has also mentioned that from 1/11/2022, the entire share of Dadri-II (i.e. 728 MW) will be with Delhi.
- 2) The same decision has been communicated to Central Electricity Authority (CEA) by MoP, Gol vide its Order dated 29/06/2022 and accordingly, NRPC has requested NRLDC and POSOCO to implement the revised allocation of Dadri-II wef 00:00 hrs of 1/07/2022.
- 3) Consequently, Dadri-II allocation to Delhi is split among DISCOMs as follows:

- 4) From above table, it is observed that the impact of Reallocation of power of Dadri-II is majorly to BRPL resulting into loss of 373 MW of Power.
- 5) The Peak Demand in Delhi has touched a level of 7695 MW on 29/06/2022, surpassing the earlier Peak Demand of 7409 MW occurred in July, 2019. The Peak Load, Avg. Load and Minimum Load on 29/06/2022 is as follows:

- 6) During Summer Preparedness meetings conducted by the Commission in March and April, 2022, it was informed by Delhi-SLDC that Peak Demand may touch 8200 MW in the month of July 2022.
- 7) It is further observed from the data submitted by Delhi SLDC that TPDDL is net seller of Power in the month of April and May, 2022.
- 8) Proviso to Regulation 121(4) of the DERC (Terms and Conditions for Determination of Tariff) Regulations, 2017 enables Commission in reassigning the allocation of Power amongst the Distribution Licensees out of the overall power portfolio allocated to the National Capital Territory of Delhi by Ministry of Power, Government of India.
- 9) In view of above, it is judiciously felt to reallocate appropriate quantum of power from TPDDL to BRPL. Since, Dadri-II is a Coal Based Plant, therefore re-allocation of Power from similarly placed another Coal Based Plant of nearly same Energy Charge Rate is the best possible solution to maintain 24x7 supply of power to all consumers of Delhi due to loss of 500 MW of Delhi's share of Dadri-II till 31/10/2022. Accordingly, the allocation of Aravali Jhajjar (Aravali Power Company Private Limited) is temporarily revised w.e.f. 00:00 Hrs. of 1/07/2022 till 24:00 Hrs. of 31/10/2022, as follows:

- 10) The impact of above Temporary Allocation shall be considered in the subsequent Tariff Order. Delhi SLDC and Distribution Licensees are directed to adhere the above revised allocation and make suitable arrangements accordingly.
