Sub.: Replacement of the Service Cable vis-a-vis Sanctioned Load of the Consumer

Ref.: Meeting held on 03.01.2012 in the Commission – Revision of Sanctioned Load based on MDI

Sir

This is in respect of revision of sanctioned load of the consumers being carried out by the Discoms, based upon the average of the 3 highest MDIs in the preceding financial year. We are in receipt of a large no. of representation from consumers regarding the issue of notices by the Discoms for deposit of total SLD charges for the revised sanctioned load.

It has been noticed that the different Discoms are using different yardsticks for levying these charges.

The existing SLD charges, as per 'Table – 4' of DERC Supply Code and Performance Standards Regulations, 2007 are as under:

## Service Line cum Development Charge

S.No.	Sanctioned Load (kW)	Amount (Rs)
1	Upto 5	3000
2	More than 5 upto 10	7000
3	More than 10 upto 20	11000
4	More than 20 upto 50	16000
5	More than 50 upto 100	31000
6	More than 100 kW (at 11kV)	50% of the cost of HT
		cables/line/switchgear

The matter has been considered and it has been decided that only the differential SLD charges for movement from one slab to another slab may be charged from the consumers whose load has to be increased due to enhancement in the MDI readings. Thus, for enhancement of sanctioned load from 4 kW to 6 kW, (6 kW - 4 kW), the consumer will have to pay the differential amount of Rs 7,000 (-) Rs 3,000 = Rs 4,000/only. Further, in cases where the differential SLD is charged from the consumer, Discoms shall replace the service line if required.

It is also directed that the service line charges shall be credited to the capital account of the concerned Discom and not charged to revenue account.

This issues with the approval of the Commission.
