- Whereas, the Petition no. 45/2013 was filed by Sh. Sanjeev Jain under Section 142 of the Electricity Act, 2003 for certain alleged violations of procedure laid-down in Regulation 49 of Delhi Electricity Supply Code and Performance Standards Regulations, 2007. The Petitioner had also prayed for granting compensation under Section 57(2) of the Electricity Act, 2003.
- 2. Whereas, vide Order dated 30.12.2014, the Commission found that the Respondent has violated the provisions of Regulation 49 of Delhi Electricity Supply Code and Performance Standards Regulations, 2007 and imposed a penalty of Rs. 10,000/- for aforesaid violation.

Whereas, in respect of compensation under Section 57(2) of the Electricity Act, 2003, the Commission had observed that the electricity supply of the Petitioner was disconnected for no reason and therefore, the Respondent has failed to achieve the standards specified in Schedule I of the Delhi Electricity Supply Code and Performance Standards Regulations, 2007. As per provisions of Schedule III of Delhi Electricity Supply Code and Performance Standards Regulations, 2007, a compensation at the rate of Rs. 50/- per day of default for the intervening period from the date of disconnection and the date of filing the petition before the Commission was also granted to the Petitioner.
- 4. Whereas, in the aforesaid Order dated 30.12.2014, inadvertently due to clerical error the days of intervening period and the amount of compensation were incorrectly mentioned as 238 days and Rs. 1,19,400/respectively, while as per the correct calculation the period of default from 12.02.2013 to 27.09.2013 is 228 days and consequently the amount of compensation at the rate of Rs. 50/- per day would be Rs. 11,400/-.
- 5. Now, therefore, the Commission under Regulations 57 (1) of the DERC (Conduct of Business) Regulation, 2001 makes the order to the effect that the period of default stands corrected to 228 days and accordingly the amount of compensation also stands corrected to Rs. 11,400/- (Rupees Eleven Thousand Four Hundred) Only.
