ORDER

1. The instant petition has been filed by Shri Shiv Charan, under Section 142 of the Electricity Act, 2003 against Tata Power Delhi Distribution Ltd. for violation of the procedure laid down in Regulation 52 and 53 of the Delhi Electricity Regulatory Supply Code and Performance Standards Regulations, 2007 while booking the case of theft.
2. Notice of the petition was issued on 18.03.2014 to Respondent to file its reply.
3. The Commission while admitting the above petition, vide its Interim Order dated 21.05.2014, directed the Respondent to show cause on the prima

facie findings of violations of Regulation 52 (x), 52 (xi), 52 (xii) and 53 (ii) of Delhi Electricity Supply Code & Performance Standards Regulations, 2007. The Respondent filed its reply to the above Show Cause Notice on 08.07.2014.

4. Subsequently, on 12.08.2014, the Commission received a letter dated 06.08.2014 from the respondent along with an affidavit dated 06.08.2014, intimating thereby that the matter had already been settled between the petitioner and the respondent company and there is no dispute in respect of the captioned matter.
5. The Commission has also received an email from Counsel of the petitioner stating that the matter has been amicably settled between the parties and the Petitioner may be allowed to withdraw the aforesaid petition.
6. The matter was listed for hearing today i.e. on 21.08.2014. No appearance was made by the petitioner or his counsel, whereas the representatives of the respondent were present.
7. In view of the facts stated above, the petition is dismissed as withdrawn.
8. Ordered accordingly.
