INTERIM ORDER

 The instant petition has been filed by Ms. Suresh Kumari under Section 142 of the Electricity Act, 2003 against Tata Power Delhi Distribution Ltd. for violation of the procedure laid down in Regulations of the Delhi Electricity Supply Code and Performance Standards Regulations, 2007.

2. The matter was listed for hearing in the Commission today, which was

attended by both the parties. During the hearing, the counsel for the

Petitioner submitted that there had been violations of Regulations under

Delhi Electricity Regulatory Commission (Performance Standards – Metering &

Billing) Regulations, 2002 and since the Speaking order was issued under the

Delhi Electricity Supply Code and Performance Standards Regulations 2007,

some Regulations of the Delhi Electricity Supply Code and Performance

Standards Regulations 2007 have also been violated.

3. The counsel for the Respondent objected to the maintainability of the

petition on the ground of limitation and stated that the petition has been

filed after seven years from the date of issuance of the Speaking order.

4. The Commission heard both the parties and directed the Respondent to file

detailed objections in respect of maintainability of the petition within two

weeks with a copy to the petitioner, who may file rejoinder within a week

thereafter.

5. The matter was adjourned. The next date of hearing shall be intimated to the

parties in due course.

6. Ordered accordingly.
