ORDER

1. The instant petition has been filed by Shri Tajuddin, under Section 142 of the Electricity Act, 2003 against BSES Yamuna Power Ltd. for violation of the procedure laid down in Regulations of the Delhi Electricity Regulatory Supply Code and Performance Standards Regulations, 2007.
2. The Commission while admitting the above petition, vide its Interim Order dated 26.08.2015, directed the Respondent to show cause on the prima facie findings of violations of Regulation 38(C), 52(viii), 52(ix), 52(x) and 52(xi),

53(ii) and 52(xii) of Delhi Electricity Supply Code & Performance Standards Regulations, 2007.

3. Subsequently, a letter dated 04.11.2015 has been received from the Respondent along with a copy of settlement dated 12.09.2015 between the parties before the Delhi Legal Services Authority. The parties have agreed to settle their dispute. As per the settlement it was agreed that the consumer shall not file any proceeding against the Respondent in respect of the settled bill and withdraw all cases pending in any court of law in respect of settled bill nor Respondent shall file any criminal complaint under Electricity Act, 2003 / withdraw the complaint, if already filed before the Special Court of Electricity, immediate after settlement.
4. The matter was listed for hearing today. No appearance was made by the petitioner or his counsel. The counsel of the respondent requested to dismiss the petition as the matter has been amicably settled between the parties.
5. The Commission acceded the request of Respondent and dismissed the petition as settled between the parties.
6. Ordered accordingly.
