ORDER

(Date of Order: 21.04.2009)

- This Commission issued an order dated 31.03.2007 introducing Intra-State ABT in Delhi w.e.f. 01.04.2007. Subsequently, Unscheduled Inter-Change charges were revised on 28.04.07 and 04.01.08 on account of change of UI charges by the CERC. The CERC has again revised the Unscheduled Inter-Change charges by a notification dated. 31.03.09 and issued the regulations "Central Electricity Regulatory Commission (Unscheduled Inter-change Charges and related matters) Regulations, 2009.
- 2. The Commission has examined the above notification. The Commission is of the view that there is a necessity to modify the UI charges for the Intra-State System of Delhi to be in synchronism with the modification effected by the CERC, as otherwise, there could be mismatches in the UI charges payable/receivable from the regional pool and the UI charges payable/receivable from the Intra-State pool. To minimize any such mismatches, the Commission hereby decides to adopt the unscheduled inter-change charges, additional unscheduled interstate Charges as notified by the CERC. Accordingly, the limits on over-drawal by the beneficiaries shall be as follows:

- 3. All the above limits shall be applicable simultaneously and for the purpose of calculation of UI charges, additional UI charges and invoking of penal provisions as per the Act/Rules/Regulation/ orders/IEGC/State Grid Code, the least of the three parameters indicated in the above table shall be considered.
- 4. As regards generators and the Distribution Licensees/Agencies, the conditions laid down above and in the CERC notification dated 30.03.2009 shall also be applicable besides the conditions stipulated by this Commission in its order dated 31.03.2007.
- 5. The charges for UI, additional UI etc. shall be paid to the Intra-State UI pool account maintained by SLDC and the payments from the pool account to the utilities shall be made by the SLDC in accordance with the procedure evolved in the meeting held in SLDC on 04.04.2007 as per directions at para 18(iii) of the Commission's Order dated 31.03.2007. Balance in the UI pool account shall be intimated to the Commission by the SLDC in the month of April of each financial year indicating the amounts available till the end of the previous financial year and the Commission shall issue necessary orders with regard to the utilization of such funds.
- 6. This order shall come into force with immediate effect. The SLDC shall make necessary adjustments with regard to mismatches if any, arising in the interim period i.e. from 01.04.2009 till the date on which this order has come into effect.
