# ORDER

(Date of Hearing 25.10.2012) (Date of Order 01.11. 2012)

- 1. The above matter was listed for hearing today in the Commission. The Petitioner submitted that he has applied for new electricity connection on 03.04.2010 and same has not been provided by the respondent. The Petitioner further submitted that the respondent has violated Regulation 16 (ii) & (iii) of th DERC Supply Code, 2007 and also violated provisions of Section 56 (i) of the Electricity Act, 2003.
- 2. Ld. Counsel for the Respondent submitted that the Petitioner before approaching this Hon'ble Commission has filed a Writ Petition (Civil) beofre the Hon'ble High Court of Delhi for the same issue wherein the Hon'ble Court granted leave to the petitioner to withdraw the said writ and directed to seek their remedies as per law.
- 3. Ld. Counsel for the Respondent further submitted that as per law, if the petitioner has any grievance regarding the Discom for not providing a new electricity connection, he should have approached the concerned Consumer Grievance Redressal Forum (CGRF) established under Section 42 (5) of the Electricity Act, 2003, which is the appropriate and concerned authority to get the matter resolved.
- 4. After hearing both the parties, this Commission is of the opinion that it would be in the interest of the petitioner to first approach the concerned appropriate authority i.e CGRF to get the matter resolved. In case the Forum hold the Respondent responsible for any violation, they may approach the Commission for imposition of penalty under Section 142 of the Electricity Act, 2003.
- 5. Accordingly, the Petitioner is directed to approach the concerned CGRF for redressal of their grievance & CGRF is also directed to resolve the grievance of the Petitioners within three months from the date of filing of their case before it.
- 6. In view of the above, the matter stands disposed-off.
- 7. Ordered accordingly.
