ORDER (Date of Order: 12.07.2016)

1. The Commission vide its order dated 31.03.2007 re-assigned long term Power Purchase Agreement (PPAs) to various DISCOMs supplying Power in National Territory of Delhi. The order dated 31.03.2007 was further reviewed vide order dated 27.02.2014 and the Commission had decided to re-allocate the power among BRPL, BYPL & TPDDL on the basis of average energy drawl for the period FY 2007-08 to 2011-12, as indicated in the following table:

2. Accordingly, the allocation of power to BRPL and BYPL in respect of power generated from the plants of National Hydroelectric Power Corporation (NHPC) is 209.42 MW and 121.10 MW, respectively. However, due to expiry of PPA of SEWA-II plant of NHPC, the power from this plant assigned to BRPL and BYPL to the extent of 7.03 MW and 4.06 MW, respectively has not been allowed beyond July 2015 vide Tariff Order dated 29.09.2015. Thus, the allocation of power to BRPL and BYPL from the plants of NHPC stands reduced to 202.39 MW and 117.04 MW, respectively.

3. Whereas, NHPC has requested the Commission to reallocate the power assigned to BYPL to any other Discom of the Delhi on the ground that BYPL is not making payments towards energy bills raised by it and has also failed to open Letter of Credit. Subsequently, NHPC vide its letter dated 22.06.2016 made the proposal specific that the entire power from NHPC allocated to BYPL may be re-allocated

BRPL. Further, BYPL offered BRPL for transfer of the said allocation

4. Whereas, while the issue was under deliberation in the Commission, the BYPL, citing the reason of financial hardship, has given consent for temporary reassignment of its allocated power from NHPC to BRPL. The proposal has been agreed to by the BRPL that the power from NHPC assigned to BYPL may be

temporarily assigned to it i.e. till 31.03.2018.

5. Now, therefore, considering the fact that the proposal has been agreed by all the three parties viz. NHPC, BRPL and BYPL, and keeping in view the public interest, the Commission has decided that entire 117.04 MW of power from NHPC allocated to BYPL shall be temporarily re-assigned to BRPL for the period from 13th July, 2016 till 31.03.2018. The renewal of PPA pertaining to SEWA-II HEP may be

considered separately based on future demand and cost benefit analysis.

6. Ordered accordingly.
